## Taking Risks

Risk-taking is an essential feature of play provision and of all environments in which children legitimately spend time at play. Our play provision aims to offer children the chance to encounter acceptable risks as part of a stimulating, challenging and managed play environment. Keeping children safe in school is very important, that hasn't changed. What we will be doing with the children is working with them to help them learn how to identify risk, assess it and decide what they need in order to proceed. The continuous discussions with the children will help us to form effective risk-benefit assessments. We hope this will give children lifelong skills that they can take with them into adulthood.



The HSE (Health and Safety Executive) agrees that play which carries some risk is not only allowed but should be actively encouraged. Children, by law, have the right to play. Their document, 'Children's Play and Leisure -Promoting a Balanced Approach', is available for you to read on our website.



#### CHILDREN'S PLAY AND LEISURE - PROMOTING A BALANCED APPROACH

- Health and safety laws and regulations are sometimes presented as a reason why certain play and leisure activities undertaken by children and young people should be discouraged. The reasons for this misunderstanding are many and varied. They include fears of litigation or criminal prosecution because even the most trivial risk has not been removed. There can be frustration with the amounts of paperwork involved, and misunderstanding about what needs to be done to control significant risks.
- The purpose of this statement is to give clear messages which tackle these misunderstandings. In this statement, HSE makes clear that, as a regulator, it recognises the benefits of allowing children and young people of all ages and abilities to have challenging play opportunities.
